The South Jersey Regional Library Cooperative Digital Audiobooks Download Center went live on January 30, 2006. In 2007 we delivered service to the following participating libraries: Atlantic City Free Public Library, Atlantic County Library System, Audubon Free Public Library, Avalon Free Public Library, Burlington County College Library, Cape May County Library, Cherry Hill Public Library, Gloucester City Library, Gloucester County College Library, Haddonfield Public Library, Linwood Public Library, Margaret E. Heggan Public Library (Washington Township), McGuire Air Force Base Library, Moorestown Library, Mount Laurel Library, Ocean City Free Public Library, Pennsauken Free Public Library, and West Deptford Free Public Library.

Since inception, we have circulated over 12,500 audiobooks from a collection of more than 1300 general interest titles (1447 copies) that we have purchased, and our annual subscription to 75 "always available" titles. We continue to add new titles and copies to the collection on a monthly basis.

Digital Audiobook Consortium Letter of Agreement
Deadline for commitment is October 1, 2007.

Participant Responsibilities:

- The Library agrees to participate in the SJRLC Overdrive Downloadable Audiobook Incubator Project for a 12-month period from January 1, 2008 - December 31, 2008
- The Library agrees to pay an annual participation cost of \$1,000 and an annual audiobook collection fee based on the library's circulation figures of the previous calendar year.* The shared access pricing structure is detailed below.

600,000 - 1,000,000	\$1,000	\$4,000	\$5,000
1,000,000 +	\$1,000	\$5,000	\$6,000

*In second and subsequent years, individual library costs will include an annual participation fee of \$1000 and a shared collection fee based on library customers' use of the shared Audiobook collection.

A signed letter of agreement and payment in full of first year fees makes the library eligible to participate fully in the project.

- The Library agrees to pay *South Jersey Regional Library Cooperative* the full amount of Year One costs by November 15, 2007.
- The Library agrees to adhere to the policies determined jointly by the *South Jersey Regional Library Cooperative* and by eligible group participants.
- The Library understands that if the institution withdraws, the content remains the property of the group.
- The Library agrees to participate in evaluation of this incubator project.

South Jersey Regional Library Cooperative Responsibilities:

- The *South Jersey Regional Library Cooperative* will contribute \$10,000 to the Shared Audiobook Project in 2008.
- The *South Jersey Regional Library Cooperative* will manage the project with Overdrive on behalf of the participants of this incubator project.
- The *South Jersey Regional Library Cooperative* will provide participants the opportunity annually to continue or discontinue participation in the project.
